Board Vote Presentation: Vice President, Treasurer and Member-at-large 1 and 3

Amy acknowledged Catrines term as a board member. She introduced the ballot and reminded attendees that there is a write in option so for anyone that has any interest in being a board member they could say so and a nomination could be made to put them on the ballot. She also spoke about the role of the Treasurer and that this would be Shelly's last term as the Treasurer, so if there were any CPA's that would be a great next step for them onto the board. The combined bookkeeper/Treasurer role is shared by Shelly (payroll and taxes) and Michelle (invoicing). The goal is to transition into the role as Treasurer by starting in the bookkeeper role and then training into the Treasurer role. Head Coach Report (Natalie)

- Coaching Staff Natalie, Lindsey, Lelsie, Clare, Freja, Janea, Jordan, Lisa, Arrie
- Event Schedule Lindsey and Arrie to convention next week in King of Prussia PA, No major votes should occur this year but there will be a lot of education around the new scoring system and changes to come. Oct 3rd mod pizza meet the team and goal setting meeting at 4:30
- Practice Schedule no major changes but will be communicated on the team placement email
- Club Gear club jackets are no longer available, so Natalie has chosen a new version, swimsuits have an option of back as well as skinny and wide straps. It doesn't matter which version you choose as long as it says PWSS. Swimmers can also have their names printed above the hip. There are also other options like tank tops, shirts and shorts, however they change from year to year. If someone purchases a jacket we would prefer to do the embroidery because swim outlet has a couple different versions of the logo on the back they use.
- Team Trials September 30th there will also be a gear swap that day as well. Trials will include speed swims, endurance, routines. Swimmers can choose Tract A or B on the routine. This does not predetermine a team based on the level chosen.
- Synchro-Thon 2023 October 28th along with the Halloween celebration
- Levels Testing Oct 21 and 22. Levels 1, 3, 5 day one levels 2, 4, 6, day two
- Water show working on dates, but there are many graduation events that families are committed to
- Mac will be hosting regionals this year on May 18 and 19. Novices do not swim at Regionals
- Blossom will be for those who do not qualify for JO's unless a Canadian team comes then possibly the older teams will compete.
- October date tbd scoring system review with parents. Will cover coach cards, requirements, factoring, protests. Bonuses, basemarks.
- USAAS has a new club excellence program. Natalie applied for it and they said it was after the deadline, so she will try again before January. We are almost at a level 2. It is a designation that is on the USAAS website and there are prizes awarded to clubs such as posters, registration discounts and more.

 - Swimsuit rental
 - No prorates except possibly September and June depending on when start and end of the year falls.
- Participation: Practices (contact team coach and Head Coach if missing), meets and clinics (30 days' notice to team coach and head coach)
- Lessons vs team
- Levels determined by trials
- Club gear:
